## Definitions:

1. Adult and Juvenile Governmental Post-Conviction Victim Service Program/Organization means: Corrections, Parole, Probation (post-conviction) of a Federal, State, or Local Government.

2. Individuals – Governmental Employees / Retiree non-affiliated includes individuals employed by governmental agencies and those retired from governmental agencies who are not currently affiliated with an allied professional organization.

3. Individuals- Non-governmental employee includes individuals who work for a non-governmental organization (whether non-profit or for-profit) and volunteers of governmental or non-governmental organizations.

4. Allied Professional Associations/Organizations includes non-governmental organizations and allied national organizations.
